The stipend will be provided along with arrear, as and when fund is made available by the Government of Assam.

While sending herewith a copy of Agreement to be executed, you are informed to come to the Gauhati High Court and execute the said Agreement on 11.10.2018 at 2.00 p.m. in the Conference Hall (2nd Floor) of the New Block of the Gauhati High Court, Guwahati. If you fail to execute the Agreement on the fixed date, it will be deemed that you are not interested to undergo the Pre-Appointment Training and in that event your selection will stand cancelled and the offer will be given to the wait listed candidates.

AGREEMENT TO BE EXECUTED BY A CANDIDATE SELECTED FOR PRE-APPOINTMENT TRAINING FOR APPOINTMENT IN THE ASSAM JUDICIAL SERVICE

(Under Rule 7, 10(iv) and Schedule D of the Assam Judicial Service (Amendment) Rules, 2008)

THIS MEMORANDUM OF AGREEMENT made this the day of month in the year of Two Thousand and Eighteen.

BETWEEN

The Governor of Assam (which term shall where the context so admits, includes his successors, representatives, subordinate or authorized officers to the Government of Assam) hereinafter referred to as, 'the State of Assam' on the ONE PART

WHEREAS the Assam Judicial Service (Amendment) Rules, 2008 (for short, 'the Rules') prescribes certain conditions as regards Pre-Appointment Training Course (hereinafter called as, 'Training Course') for direct recruitment in Grade-III of the Assam Judicial Service (for short, 'the AJS').

AND WHEREAS the Rules requires a candidate, selected for undergoing the Training Course, to execute an agreement that on successful completion of the Training Course, he/she will serve the State of Assam for a period of 5 (five) years and in the event the candidate does not successfully complete the training course or on successful completion thereof, he fails to serve the State for the minimum period of 5 (five) years, such candidate shall be required to reimburse an amount, as may be decided by the Gauhati High Court (hereinafter called as, 'the High Court').

AND WHEREAS the Trainee has been selected for undergoing the course for a period of 1 (one) year in such institution as decided by the Hon'ble High Court in due course prior to appointment in Grade-III of the Assam Judicial Service.

NOW THIS MEMORANDUM WITNESSETH the terms and conditions of the above written obligation and it is agreed by and between the parties hereto as follows:-

- 1. That the duration of the Training Course will be 1 (one) year.
- 2. The Trainee shall be paid such monthly stipend along with arrear as may be fixed by the High Court, as and when fund is made available by the Government of Assam.
- 3. The Trainee will have to qualify in an examination to be conducted by the concerned Institute/School/Academy.

- 4. The Trainee shall acquire adequate working knowledge of the Official Local Language(s) of the State of Assam and for such purpose the Trainee will be required to pass a written test and a oral test in such Official, Local Language(s) as a condition of satisfactory completion of the Training Course.
- 5. After successful completion of the Training in the concerned Institute/School/Academy, the Trainee will be appointed in the service. They may, however, be required to undergo a further orientation/ acclimatization course of 4-6 weeks, if deemed necessary by the High Court.
- 6. The Trainee will have to serve the State of Assam for a minimum period of 5 (five) years. In the event the Trainee does not successfully complete the Training Course or on successful completion thereof he/she fails to serve the State for a minimum period of 5 (five) years, such Trainee shall be required to reimburse such amount, as may be decided by the High Court.
- 7. In the event of the Trainee Committing breach of any of the above terms and conditions, the whole of the amount of entire cost of the Training or, such lesser sum as may be decided by the High Court, so spent during the Training Course undergone by the Trainee shall become payable by the Trainee to the Government of Assam and the Trainee shall be liable to make such payment to the State of Assam on demand and the State of Assam shall without prejudice to any rights and remedies, recover the same from the trainee in accordance with the procedure prescribed under Bengal Public Demands Recovery Act, 1913.
