NOTIFICATION No.29

Dated Guwahati, the 20th June, 2018

In partial modification of this Registry's earlier Notification No. 88 dated 22nd November, 2012, Hon'ble the Chief Justice has been pleased to extend the following assistance/facilities to Hon'ble Retired Chief Justices/ Judges/ Additional Judges of Gauhati High Court:-

- (i) *Facilitate appointment from Doctors of various hospitals and dispensaries;*
- (ii) *Provide assistance/service for reservation of Railway and Air tickets;*
- (iii) *Provide Car on payment (rate to be fixed) subject to availability;*
- (iv) *Provide use of Library of the High Court;*
- (v) *Provide services for reservation of rooms in Houses/ Bhawans of respective States of North Eastern Region; and*
- (vi) *Provide services for payment of various bills like water bill, electricity bill, telephone bill and also to provide services for registering complaint against other public utility services.*

The above facilities be provided to retired Hon'ble Chief Justices and Judges provided they are not availing the facilities of Secretarial and Domestic help or any cash facility in lieu thereof from any other High Court/Supreme Court/Government/ Organisations and / or joining regular practice as a legal professional in any Court or accepted any assignment or any nomenclature, having pecuniary benefits.

The above facilities will also be extended to all the Retired Chief Justices/ Judges/ Additional Judges of Gauhati High Court, who are engaged in various capacities but not receiving the above assistance/ facilities, due to lack of manpower, infrastructure, budget etc in their present assignments.

The Protocol Section of this Registry, in liaison with the Hon'ble Judge concerned, shall provide the services as mentioned above.
