The Gauhati High Court has been pleased to call for options provisionally (in the prescribed format of application annexed with this Notification) from the serving Stenographers of the District Courts of Assam, who are eligible as per the criteria indicated below, for preparation of a panel of eligible Stenographers for promotion to Stenographer Grade-I and Stenographer Grade-II against the available sanctioned vacancies in the District Courts of Assam.

Options are called from Stenographers who fulfill the following criteria, as on the last date of submission of options:

- i. Irrespective of any grade and educational qualification they possess, existing Stenographers, who have completed 5 (five) years of service for promotion to Stenographer Grade-I.
- ii. Irrespective of their educational qualification they possess, existing Grade-III Stenographers, who have completed 5 (five) years of service for promotion to Stenographer Grade-II.

Stenographers, who are working on contingent/contractual/ad hoc/wages basis etc., are not eligible to take part in the promotional process.
