ORDER

No. HC.V-97/2016/ 832 /Estt.### Sri Kuladeep Kumar Haloi is temporarily appointed in the post of Judicial Assistant in the Principal Seat of the Gauhati High Court, vice Sri Manash Pratim Kalita, who is relieved from the service of the Gauhati High Court, in the revised scale of pay of Rs.14000-49000/-(PB-2) with Grade Pay of Rs. 8700/- per month plus other allowances, as admissible under the Rules, with effect from the date of his joining, subject to the condition that in the event of adverse police verification report, his service will be terminated forthwith without assigning any reason whatsoever.

The service of Sri Haloi will be governed by "The New Defined Contribution Pension Scheme" issued by the Government of Assam, Finance (Budget) Department vide office memorandum No.BW.7/2008/Pt/40, Dtd. Dispur the 6th October, 2009. He has to submit an undertaking to that effect at the time of joining the Registry of the Gauhati High Court, Guwahati.

He will be on probation for a period of one year with effect from the date of his joining. He is directed to join his duty within 15 (fifteen) days from the date of receipt of this order.

Further, he has to submit his medical certificate of fitness from Medical Officer of Govt. or from any Medical-Officer-in-charge of a Civil Station to this Registry at the time of joining.

The above candidate, if presently, employed in Central/ State Government service shall have to submit release order from the former employer at the time of joining.
