Selection process for Lawn Attendant/ Mali:

The following shall be the selection process for recruitment to the post of Lawn Attendant/Mali:

| Stage 1 | Written examination of one paper of 50 marks. The written examination (objective type multiple choices) will be of 1½ hour duration on OMR answer scripts and the same shall contain questions on General Knowledge, General English & General Aptitude. |
| Stage 2 | Candidates equal to 5 times the number of vacancies (1:5) in order of merit in the written examination shall be called for viva-voce of 15 marks. The Gauhati High Court shall reserve the right to fix cut off marks in the Written Examination. On the basis of the total of marks obtained in written examination and viva-voce the final select list will be prepared. <i>(Note: In case of candidates obtaining equal marks (in written examination and viva-voce), one who obtains more marks in the written examination will be given preference. Where the marks obtained by such candidates in the written examination are also same, the candidate who is senior in age will be given preference.)</i> |

Selection process for Chauffeur/Driver

The selection process for the post of Chauffeur/Driver has already been notified in the Advertisement dated 08-02-2018.

Specific Venue of the Written Examination/Driving Test will be indicated in the Admit Cards of the candidates.

Admit Cards for the Written Examination/ Driving Test of respective posts will be issued to the candidates by post. If any candidate does not receive his/her Admit Card on or before 12-12-2018, he/she can collect the same in person from the Registrar, Gauhati High Court, Itanagar Permanent Bench, Naharlagun, Arunachal Pradesh on 13-12-2018 during office hours.

Provisional lists of eligible candidates with assigned Roll Nos. and reject lists of candidates with reasons for rejection have been published along with this notification.

Further, due to non-submission of caste certificate, some of the candidates have been included in the unreserved category of the provisional eligible list.

The eligibility of the candidates is still under scrutiny and the High Court reserves the right to reject the candidature of any candidate on detection of any ineligibility condition at any stage.


