## 3. ELIGIBILITY & SELECTION CRITERIA FOR DRIVER

### (A) Eligibility Criteria

- The candidate must have passed Class-VIII standard.
- Those who have passed HSSLC or above shall be ineligible to apply for the said post.
- He must be holder of valid driving license.

### (B) Selection Criteria

Candidates will have to appear in a skill test of 50 marks. The cut off marks of skill test shall be as decided by Gauhati High Court. Thereafter, the candidates equal to 3 times of the number of vacancies (1:3), in order of merit in the skill test, will be called for viva-voce of 10 (Ten) marks and checking of original testimonials. On the basis of marks obtained in skill test and viva-voce the final panel will be prepared. However, final selection shall be subject to overall suitability to be decided by the Gauhati High Court.

Provided that depending on the number of applicants, Gauhati High Court may decide to hold a written test of 20 marks (Objective type with multiple choices) on OMR answer scripts on English & General Knowledge prior to holding of skill test and call only those candidates to skill test, who qualify in the written test. The qualifying marks of written test shall be as decided by the Gauhati High Court.

*(Note: In case of candidates obtaining equal marks (in Driving Test and viva-voce), one who obtains more marks in the Driving Test will be given preference. Where the marks obtained by such candidates in the Driving Test are also same, the candidate who is senior in age will be given preference.)*



## 8. ELIGIBILITY & SELECTION CRITERIA FOR LAWN ATTENDANT/MALI

### (A) Eligibility Criteria

- (a) The candidate must have passed Class-VIII standard.  
(b) Those who have passed HSSLC or above shall be ineligible to apply for the said post.

### (B) Selection Criteria

<b>Stage 1</b>	Written examination of one paper of 50 marks. The written examination (objective type multiple choices) will be of 1½ hour duration on OMR answer scripts and the same shall contain questions on General Knowledge, General English & General Aptitude.
<b>Stage 2</b>	<p>Candidates equal to 3 times the number of vacancies (1:3) in order of merit in the written examination may be called for viva-voce of 10 marks.</p> <p>The Gauhati High Court shall reserve the right to fix cut off marks in the Written Examination. On the basis of the total of marks obtained in written examination and viva-voce the final select list will be prepared.</p> <p><i>(Note: In case of candidates obtaining equal marks (in written examination and viva-voce), one who obtains more marks in the written examination will be given preference. Where the marks obtained by such candidates in the written examination are also same, the candidate who is senior in age will be given preference.)</i></p>

## 8. HOW TO APPLY

- a) Candidates are first required to go to the website [www.ghconline.gov.in](http://www.ghconline.gov.in), download and take printout of the common "**Application Form**" available along with this advertisement.
- b) Fill in the "**Application Form**" in a clear and legible handwriting in BLOCK LETTERS.
- c) Application Fee have to be paid in the "Demand Draft" or "IPO" of appropriate Application Fee. The fee once paid will not be refunded in any case. Bank transaction charges will have to be borne by the candidates. The details of fee to be paid are indicated below:

- d) Candidates should obtain the Candidate's Copy of the "Fee Payment", duly authenticated by the Bank or Post Office with (a) Branch Name & Code No , (b) Date of Deposit & amount.
- e) In case candidate fails to deposit the fee, and fails to submit the "Demand Draft or IPO" along with the application form, his/her application shall be cancelled / rejected without further communication and shall not be considered for further processing.
- f) Candidates shall, thereafter fill the common Application Form and paste his/her recent passport sized coloured photograph in the given space of the application form and shall sign across the photograph. Two Self attested copies of the same photograph should be stapled in the top right corner of the application form and the candidate should write his/her name on the reverse of the stapled photographs. The envelope containing the application form should be super scribed as **"APPLICATION FOR THE POST OF....."** indicating the choice of post of the candidate in the blank space and the same should be addressed and send to **"The Registrar, Itanagar Bench, Gauhati High Court, Naharlagun, Arunachal Pradesh, Pin-791110"** within 15 (Fifteen) days from the date of publication of the advertisement.
- g) **The envelope containing the Application Form should be sent by post so as to reach the aforementioned addressee on or before the last date. The Gauhati High Court will not be responsible for late receipt/non receipt of application forms.**
- h) **Applicants need to submit photocopy of the documents, along with the following, along with the application:**
- (1)The "Demand Draft/IPO" in original. The candidate should keep a photocopy of the Demand Draft/IPO for his own record.**
- (2)Passport photos as indicated in sub-clause (f) above.**
- i) Separate application will have to be submitted for applying for more than one post by paying separate fees therefor.
- j) Candidates who are already in Govt. Service will have to submit "No Objection Certificate" from proper authority at the time of viva-voce and checking of original document, if shortlisted for viva-voce.
- k) The list of the candidates, with allotted Roll Nos. will be published on high court website for reference of the candidates after closure of Advertisement.



**9. TERMS AND CONDITIONS:**

- (a) Candidates will have to appear for Written Test/Skill Test/Interview etc. as and when called for. No TA/DA will be admissible for that purpose.
  - (b) The Gauhati High Court reserves the right to cancel the advertisement/alter/modify or change any of the terms and conditions including selection criteria etc. spelt out in the advertisement.
  - (c) The certificate for the claim of reservation must be issued by competent authority.
  - (d) Merely satisfying the eligibility criteria do not entitle a candidate to be called for written test/skill test/viva-voce etc.
  - (e) No person who has entered into or contracted a marriage with a person having a spouse living or who, having a spouse living has entered into or contracted a marriage with any person, shall be eligible for appointment to the service.
  - (f) The admission of candidates at all stages of the selection process will be purely provisional and subject to their satisfying the prescribed eligibility conditions by way of furnishing documentary evidence in support thereof. If on verification at any time before or after the selection process, it is found that a candidate does not fulfill any of the eligibility conditions, his/her candidature shall stand cancelled without any notice. Mere calling of candidate to written examination/skill test/interview etc. and mere issuance of admit card/call letter etc. does not necessarily mean acceptance of candidature of any candidate which shall be further scrutinized at every stage and Gauhati High Court reserves the right to reject the candidature of any candidate at any subsequent stage of the selection process.
  - (g) Gauhati High Court may put the finally selected candidates on probation for a particular period to be decided by the Gauhati High Court. Gauhati High Court reserves the right to reject the candidature of any candidate during the period of probation.
  - (h) Posting and transfer of the finally selected candidates shall be as decided by the Gauhati High Court.


