The Gauhati High Court has been pleased to call for options provisionally (in the prescribed format of application annexed with this Notification) from the serving Stenographers of the District Courts of Assam, who are eligible as per the criteria indicated below, for preparation of a panel of eligible Stenographers for promotion to Stenographer Grade-I and Stenographer Grade-II against the available sanctioned vacancies in the District Courts of Assam.

Options are called from Stenographers who fulfill the following criteria:

- i. Irrespective of any grade and educational qualification they possess, existing Stenographers, who have completed 10 (ten) years of service.
- ii. Irrespective of their educational qualification they possess, existing Grade-III Stenographers, who have completed 5 (five) years of service.

The Stenographers, who furnish their options, will have to appear in a Speed Test as indicated below:

5.	Candidates securing 30 or more marks out of 50 will be eligible for promotion to Grade-I	
Speed Test for Promotion to Grade-II		
1.	Voice testing before dictation	2 minutes
2.	Speed test in Shorthand at a speed of 80 words per minute (Duration 7 minutes) [560 words]	50 marks
3.	Time to be given to the candidates for testing the Computer	3 minutes
4.	Time for transcription of the dictated portion	20 minutes
5.	Candidates securing 30 or more marks out of 50 will be eligible for promotion to Grade-II	

Stenographers, who are working on contingent/contractual/ad hoc/wages basis etc. are not eligible to take part in the promotional process.

The District & Sessions Judges/Presiding Officers/Chief Judicial Magistrates of the District Courts of Assam are requested to forward the scanned copies of options (as per format annexed) of the eligible Stenographer(s), if any, of his/her establishment, by email at ghcrCELL.2013@gmail.com on or before **30-11-2017 (Thursday)** during office hours. The original copies of the options (as per format annexed) may be sent by post addressed to the undersigned.

On receipt of options, the date, time and venue of the Speed Test will be notified in due course.


