	The Driving Test will be of 4 (four) sections namely, Starting, Driving, Parking and After Driving (10 marks for each segment, total 40 marks).

Stage 2	The candidates will be assessed on the touchstone of General Awareness, Personality, Experience and Suitability (20 marks).
